

# Playground Regulations

## BAGNO IL FARO

The bathing establishment has deemed it appropriate to stipulate a few simple rules so that the children's playground area corresponds to the purpose for which it was created.

The games in the playground area are to be used exclusively by children.

Any consumption by children and adults must take place outside the playground area.

It is forbidden to throw any objects, paper, stones, cigarettes, and anything else that may create dirt into the playground area.

It is strictly forbidden to bring animals into the playground area.

It is strictly forbidden to bring personal items or toys into the playground area that are not CE-compliant.

No leather balls may be brought into the playground area, only sponge or inflatable balls.

The playground area is reserved for children between the ages of 2 and 10 years.

Children in the play area must be accompanied and/or supervised by their parents or guardians.

THE MANAGEMENT DECLINES ALL RESPONSIBILITY IN THE EVENT OF DAMAGE AND/OR ACCIDENTS CAUSED BY NON-COMPLIANCE WITH THE ABOVE RULES OR IMPROPER USE OF THE GAMES.

# REGULATION OF PLAY GROUNDS

## BAGNO IL FARO

### ART. 1 - RENTAL COSTS

The modular courts for Beach-volley; Beach-tennis; Beach-soccer; Foot-volley and the Street-Basket field are free of charge for the clients of the bathing establishment BAGNO IL FARO.

These courts can be rented at hourly periods.

For outside patrons, the rental costs are at the hourly rate.

The hourly rate for the camps is the price of a daily sunshade:

- a) ECONOMY category in the Morning;
- b) BASE Category in the Night.

### ART. 2 - RENTAL MODALITIES

Camps can be rented from the Management of the establishment by showing a valid identity document, driving licence or health card, which must be left at the Management and collected at the end of the rental period.

Minors may also rent the pitches if accompanied by an adult with the documents listed in the previous paragraph.

The Management and the staff of the establishment will regulate the entrances and supervise the smooth running of the activities.

The tenant of the courts shall be personally liable for any damage caused to the facility (fencing nets, goal nets, volleyball nets, poles, ground strips, protections, banners and any equipment that is part of it) or to any equipment supplied (beach balls, footballs, rackets, poles, etc.).

A minimum of 4 and a maximum of 12 players per hour are permitted on the beach courts. In the football pitch a minimum of 4 and a maximum of 6 adults and 8 children players per hour are permitted.

On the street-basketball court, a minimum of 2 and a maximum of 4 players per hour are permitted.

All courts may be rented from time to time for the organisation of tournaments and sports events.

In this case, customers may not use them on the days of the events, unless they have signed up to participate in the tournaments, which will be communicated in advance within 48 hours beforehand.

### ART. 3 - RENTAL HOURS

Beach-volleyball; Beach-tennis; Beach-soccer; Foot-volley  
are rented according to the following times:

MORNING: from 8:30 a.m. to 8:30 p.m.

AFTERNOON: from 20:30 to 00:30.

The Street-basketball court is rented according to the following times:

MORNINGS: 9 A.M. - 12 NOON

AFTERNOON: 4 P.M. - 7 P.M.

## REGULATIONS BAGNO IL FARO

The purpose of the following regulations is to protect the safety and well-being of the Customers, as well as order and cleanliness inside the bathing establishment in concession to BAGNO IL FARO della Luce S.r.l.

Every customer is obliged to comply with all laws and regulations governing bathing activities in general.

~ The use of the services can only take place during the opening hours of the bathing establishment (from 8 a.m. to 8 p.m. on holidays and pre-holidays from 7.30 a.m. to 8.30 p.m.) and is conditioned by the signing of the application form to these regulations, as well as by the advance payment of the amounts corresponding to the services requested, according to the rates set out in the price list of the Establishment itself.

There are no hourly rates.

After 3:30 p.m., the Management reserves the right to apply price reductions on the cost of the station.

~ Telephone bookings are considered confirmed after payment of a deposit by bank transfer.

~ Each beach umbrella can accommodate a maximum of 4 people (including children), so it is recommended not to exceed this number in order to avoid unpleasant crowding.

The number of persons is considered to be the number of persons entering the Resort and it is therefore irrelevant whether children or teenagers stay under the parasol.

Should the number of occupants of the parasol exceed these limits, the Management may resort to terminating the rental and/or requesting the rental of an additional parasol.

~ For each parasol place there are 2 pieces: sun loungers or deckchairs in the shape requested by the customer.

An additional seat under the same umbrella may be added for an extra charge. The Management itself will decide the maximum number allowed, depending on the position of the umbrella itself, so as not to hinder the pleasant stay of other customers

~ Each gazebo can accommodate a maximum of 7 people (including children) so it is recommended not to exceed this number to avoid unpleasant crowding.

The number of persons is considered to be the number of people entering the Establishment and therefore it is a circumstance that children or young people do not stay under the Gazebo. Should the number of occupants of the Gazebo exceed these limits, the Management may resort to terminating the rental and/or request the rental of an additional parasol or Gazebo.

~ For each Gazebo space there are 2 pieces: sun loungers or chairs in the shape requested by the customer; 1 small table and 4 beach chairs .

They can be added by paying 2-3 extra for those inside the perimeter of the gazebos, while those around the perimeter will be decided by the Management itself, depending on the position of the other neighbouring structures so as not to hinder the pleasant stay of other guests. Gazebos or dog beds (for 4-legged friends) may be added to the basic location, but cannot be hired separately.

~ The customer must keep the ticket for the purchased services and show it at the entrance to the beach to the accompanying staff and at every request of the staff in charge.

Persons not in possession of the ticket and found using the establishment's facilities shall pay the full price of the beach place for the entire day.

We are grateful that the ticket will be returned at the end of the rental period to the beach staff so that the places can be tidied up.

~ You may not bring your own beach equipment (parasols, deckchairs, sunbeds, etc.) into the establishment. In addition, you may not keep mattresses or giant inflatables that could obstruct passage between the beach umbrellas. To this end, they must be kept out of the water in special areas as instructed by the beach staff.

~ Animals of any species may be brought into the establishment if previously shown to the staff of the establishment on a leash and where required a muzzle as required by the request made by LUCE Srl to the municipality and the Castiglione della Pescaia harbourmaster's office for their presence at the establishment.

Pets are allowed to walk on a leash along the entire foreshore (5 metres from the sea water) of the seafront, including the other Establishments and all the free beaches, while parking is prohibited;

It is prohibited to bathe and stand with one's pet outside one's own beach umbrella or those who give explicit approval.

~ It is not allowed to bring into the area of the Bathing Establishment BAGNO IL FARO with food and drinks bought outside the lido or prepared at home, except for food for babies or for people with intolerance or allergy problems.

In this case, the management will authorise such a container. It is not permitted to eat meals on the beach with the exception of meals prepared and purchased at the beach bar or restaurant.

~ The use of tables and chairs is reserved for bar and restaurant customers, who may only use them to consume purchased products.

Waste must be placed in the appropriate containers in accordance with the law.

~ It is possible to play beach-volleyball, beach-tennis, beach-soccer, foot-volley, street-basketball, football in general, exclusively in specially equipped areas.

Play and use of the STREET-BASKET platform is not permitted from 12.30 p.m. to 4.30 p.m. and from 7.30 p.m. to 00.30 a.m. of each day, unless explicitly notified by the management.

~ The management is not liable for objects and valuables in general left in the cabins and changing rooms or otherwise unattended.

~ Issued tickets are non-refundable.

No refunds will be made for subscriptions or day tickets in progress for any reason whatsoever (second thoughts, bad weather, high tide, storm surges, natural disasters, or for any other reason...etc.), much less is it possible to make up for non-use of tickets, whatever the cause.

~ The positioning of rented equipment (sun loungers, chairs and deckchairs), the use of which must be solely for the intended function, is limited to the area directly in front of the beach umbrella, in the relevant row. For this reason, chairs and sunbeds may not be moved away from the assigned beach place so as to encroach on the space of the neighbouring place. Chairs or sunbeds may not be removed from other beach places.

~ The use, even partial, of the equipment of a vacant beach umbrella, adjacent to one's own spot or positioned elsewhere will result in the immediate charge of the amount of the same. To this end, checks will be carried out on the beach by authorised personnel who will report any irregularities to the Management.

~ The toilets at the BAGNO IL FARO are reserved for the customers of the Establishment as well as for the customers of the bar and the Restaurant and are available free of charge.

Showers and foot washers are available exclusively to guests of the Resort.

Hot showers cost € 1.00.

~ The validity of periodic subscriptions and day tickets are subject to the punctual observance by customers of the conditions listed in these regulations.

~ For the needs of hygiene, morality and mutual tranquillity of the customers of the Bathing Establishment BAGNO IL FARO and in case of infringement of any of the rules mentioned in these regulations, the Direction of BAGNO IL FARO reserves the right to terminate, without any obligation whatsoever, the rental contract subscribed acquiring the right of access to the beach, with consequent loss for the customer of the sums paid for this purpose.

The Management also reserves the right not to accept bookings from customers who in the past have behaved incorrectly or in a detrimental way towards the BAGNO IL FARO establishment and its customers.

# SWIMMING RULES

## BAGNO IL FARO

### ARTICLE 1 - RENTAL COSTS

Nautical equipment:

PEDALOT, CANOE, SUP and SURF of the bathing establishment BAGNO IL FARO; can be rented at hourly periods.

Rental costs are at the hourly rate.

The hourly rate is for:

PEDALO € 20.00

CANOE € 12.00

SUP € 15,00

SURF € 15,00

### ART. 2 - RENTAL METHODS

Nautical equipment can be rented from the Management of the establishment by showing a valid identity document, driving licence or health card, which must be left at the Management and collected at the end of the rental period.

Minors may also rent nautical equipment only if accompanied by an adult with the documents listed in the previous paragraph.

There are no reservations on boats .

The ORDER of the use of the boats will be marked by the presence of the customer present when the boat is handed over, giving precedence according to the time of the payment for the service, which is made at the purchasing channels of the Establishment.

The Management and staff of the Establishment shall regulate the entrances and supervise the smooth running of activities.

The boat renter shall be personally liable for any damage caused to the nautical equipment (hull, rudder, ladders, fencing, ropes and any equipment that is part of it) or to any equipment that may be provided (life jackets, jackets, donuts, etc.).

The following are allowed in the nautical equipment

- a minimum of 2 and a maximum of 6 people on the pedalots;
- a minimum of 1 and a maximum of 2 persons on SUP;
- a maximum of 1 person on Surfboards and Canoes.

### ART. 3 - RENTAL TIMES

Nautical equipment is rented from 8 a.m. to 7 p.m.
